UNITED WATER NEW ROCHELLE INC./SABER DOBBS FERRY, LLC - The Commission decided that the petitioners' proposal is a reasonable alternative to Part 501's and UWW's tariff's requirements that satisfies the interests of the parties, and does not discriminate against ratepayers or potential ratepayers. UWW, and indirectly its ratepayers, avoid \$483,229 in costs that would otherwise be incurred while benefitting from the off-site improvements. Given this finding, the petitioners' request for a waiver under §501.10 is granted.
